PUBLICATION OF THE EXPLANATORY SUMMARY OF THE SOUTH AFRICAN POST
OFFICE SOC LTD AMENDMENT BILL

*(Published in accordance with Rule 276 of the Rules of the National
Assembly)*

1. Notice is hereby given in terms of Rule 276(1)(b) of the Rules of the National Assembly of the Parliament of the Republic of South Africa, that the Minister of Communications and Digital Technologies intends to introduce the South African Post Office SOC Ltd Amendment Bill, 2022 in the National Assembly shortly.
2. The Explanatory summary of the Amendment Bill is hereby published in accordance with Rule 276(1)(c) of the Rules of the National Assembly.
3. The Amendment Bill aims to expand the mandate of the South African Post Office Soc Ltd provided for in the South African Post Office SOC Ltd Act, 2011 and the Postal Services Act, 1998; repurpose the South African Post Office SOC Ltd infrastructure to provide diversified and expanded services whilst exploiting the infrastructure capacity to extract value and forge partnerships with other stakeholders; revise the governance structure by establishing, appointing including detailing the functions of the Stamp Advisory Committee; and to provide for matters connected therewith.
