

URGENT MEDICINE RECALL

CLASS I – TYPE A

Dear iDEXIS Customers

The South African Health Products Regulatory Authority (SAHPRA) is recalling **Semaglutide, Tirzepatide** and **Semaglutide/Tirzepatide Combination** products compounded by iDEXIS (Pty) Ltd Sentra Pharmacy trading as located at 521 Moreleta Street, Silverton, Pretoria, 0187.

This recall is initiated due to potential **serious safety concerns of the above-mentioned products** identified during the investigation inspection conducted by SAHPRA joint with SAPC at iDEXIS (Pty) Ltd /Sentra Pharmacy on 11 May 2026. To protect the patients' wellbeing, SAHPRA seized the **Semaglutide, Tirzepatide** and **Semaglutide/Tirzepatide Combination** products compounded onsite and resolved **to recall all the above-mentioned products currently in the market.**

This recall applies to **all distributed** products in the market containing either **Semaglutide, Tirzepatide or Semaglutide/Tirzepatide Combination** batches compounded at iDexis (Pty) Ltd Sentra Pharmacy trading as located at 521 Moreleta Street, Silverton, Pretoria, 0187. The recalled batches include those listed below in table 1 but are not limited to the listed as unknown batches have already been distributed prior to the SAHPRA inspection.
