SCHEDULE

Definition

1. In this Schedule “the Regulations” means the Regulations made under the Immigration Act, 2002 (Act No. 13 of 2002), published under Government Notice No. R.615 in Government Gazette No. 27725 of 27 June 2005.

Amendment of regulation 2 of the Regulations

2. The following regulation is hereby substituted for regulation 2 of the Regulations:

“2. The following fees, referred to in section 7(1)(i) of the Act, shall be payable in respect of the applications specified:

Short title and commencement

3. These Regulations shall be called the First Amendment of the Regulations on Fees and shall come into operation on the date of publication hereof in the Government Gazette.
